
BE IT FURTHER RESOLVED, that the Director of the Department of Budget and Personnel Services be directed to pay any other services rendered in connection with said General Election.

PASSED this 6th day of November, 2025.


AND, BE IT FURTHER RESOLVED, that this Resolution shall take effect on the date of its adoption.
