Seeking Input!

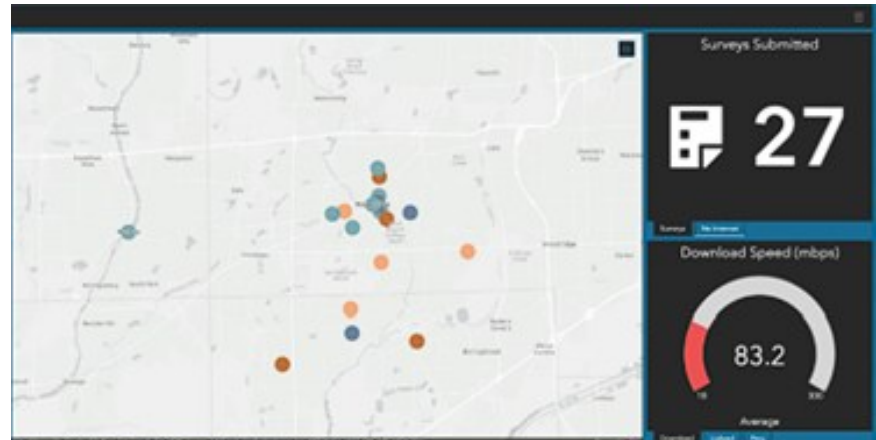
The City of Laurel Department of Information Technology has working relationships with most broadband internet and cellular service providers that operate within Laurel, and is launching an initiative to help ensure that those providers can better serve our residents. Reliable connectivity is essential for work, education, emergency services, and community engagement – yet there are some areas in the City that experience spotty mobile signals or limited options for broadband internet.

To accurately identify those coverage gaps, we're launching an initiative to identify areas in the City that are underserved by broadband internet providers, or have poor cellular coverage from their carriers. We are asking Laurel residents to help by reporting areas of concern at www.cityoflaurel.org/connectivity.

This survey is one part of a broader initiative to ensure that everyone in Laurel has equitable access to modern connectivity.

As your local IT Department, we're committed to advocating for improvements that benefit the entire Laurel community. By sharing your experiences, you empower us to encourage providers to invest in expanding service where it's needed most.

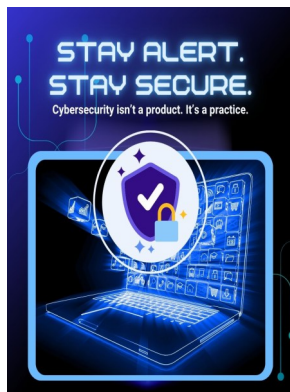

Cyber Safety Tips

The holiday shopping season has arrived, and the Department of Information Technology has some important advice to help you avoid scams while shopping online. According to the Federal Trade Commission, scams and fraud resulted in a staggering loss of over \$8.8 billion last year. Thus, it's essential to prioritize your safety during online purchases, whether it's the holidays or year round. Cyber criminals are constantly searching for weaknesses in your devices or internet connections and may attempt to steal your personal and financial information through fake websites or charities.

The best defense against these threats is awareness:



- **Create Strong Passwords:** Avoid reusing passwords across accounts. Considering using a password manager to generate and store complex, unique passwords.
- **Activate Multifactor Authentication (MFA):** MFA adds a critical layer of protection by requiring a second form of verification (e.g., a code sent to your phone or app).
- **Think Before You Click:** Be cautious with links in emails, texts, or social media ads. Phishing attempts often mimic trusted brands!
- **Regularly Software and Devices Updated:** New vulnerabilities are discovered every day. Regularly install updates for your operating system, browsers, and antivirus software to protect against the latest threats.
- **Shop Only Through Trusted Sources:** Stick to retailers you can verify. Look for "https://" in the URL and verify the site's legitimacy before entering personal or payment information. Watch out for lookalike web sites!
- **Phishing:** Be skeptical of emails or messages that create urgency or ask for sensitive information, especially with banks and retailers. When in doubt, go directly to their website instead of clicking links.
- **Use Credit over Debit:** Credit cards typically offer better fraud protection and make it easier to dispute unauthorized charges. Monitor your accounts regularly to catch suspicious activity early!
- **Secure your Wi-Fi:** Avoid shopping on public Wi-Fi. If necessary, use a VPN to encrypt your connection.
- **Data Breach Check:** Check to see if your email has been involved in a data breach at www.haveibeenpwned.com.

Keep security as your top priority, adhere to best practices, and if you're ever in doubt, it's best to avoid the risk. Safe Shopping!

STOP TRASH OVERFLOW...COMPOST AND RECYCLE!



With organics recycling now in full swing, some residents may have noticed a sticker on their trash...before you see red, read further! Managing trash over flow is as easy as 1, 2, 3. (1) remove all food waste and other organic materials (paper napkins, pizza boxes, corn husks, etc.) and put into the tan cart; (2) put all recyclable materials in the blue cart (cans, glass/plastic bottles and newspaper/flyers, etc.); (3) limit black cart items to items that are not recyclable or allowed in organics recycling – diapers, tissues, paper towels with chemical cleaners on them. Carts are available in different sizes to fit your needs. Find you are having a lot of recycling or composting items filling up your carts now that you are separating out these materials from the regular refuse stream? Residents can have more than one blue and

tan carts. We are here to help! If you are still having questions about what you can and can't recycle/compost, download the Recycle Coach app or ask for a 2025 Municipal Calendar! Both the app and the calendar show you the best way to recycle, compost and reduce trash overflow. If you need a larger cart or additional recycling or composting carts, e-mail DPW@laurel.md.us. And with Halloween behind you, now is a great time to compost your pumpkins (remember to remove all wax and candles before putting your pumpkins in your curbside cart)!

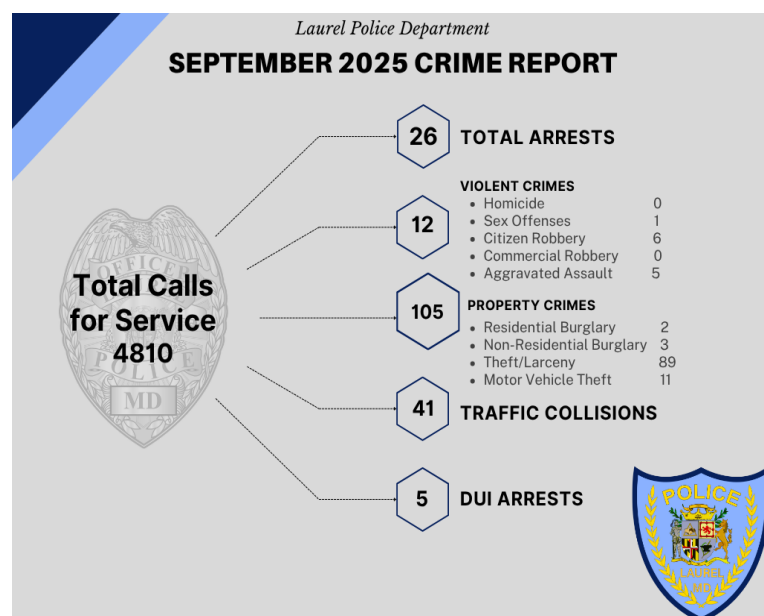

Emergency Management: Holiday Safety Tips (Preparedness Countdown!)

Holiday Preparedness Countdown

Check out our preparedness gift giving guide below!

1 Keep turkey fryers at least 10 feet away from your house.

2 Do not overfill a turkey fryer with oil. Test the amount with water.

3 Fully thaw your turkey before frying to reduce splattering.

4 While Black Friday shopping, keep an eye on your belongings.

5 Park in well-lit areas and pay attention to your surroundings.

6 Shop online with reputable retailers via encrypted websites.

7 Plan out your holiday display to avoid overloading outlets.

8 When using a ladder, always maintain 3 points of contact.

9 Turn off all decorations before leaving or going to bed.

10 If traveling, plan ahead and leave early to avoid traffic.

11 Designate a sober driver to ensure everyone arrives safely.

12 Review TSA's security screening and carry-on tips prior to flying.

13 Ensure toys are age-rated for safety to avoid choking hazards.

14 When giving riding toys, include safety gear like helmets.

15 Give the gift of preparedness with an emergency supply kit.

16 Keep your tree at least 3 feet away from heat sources i.e. fireplaces.

17 Place breakable ornaments out of reach of small children.

18 If using a artificial tree, confirm that it is fire resistant.

19 Wash your hands frequently when handling food.

20 Use separate cutting boards for raw meat and fresh produce.

21 Leftovers are safe for 3 - 4- days when properly refrigerated.

22 Test your smoke and carbon monoxide detectors.

23 Create an emergency plan with your family and practice it.

24 Stay safe and be well this holiday season!
