5. FOREST STAND DELINEATION COMPONENTS

The following items **MUST** be submitted with the Forest Stand Delineation Application. Sec. 20-41.5 of the Unified Land Development Code contains a detailed listing of the pertinent informational items required for review. These are provided below. Three (3) copies of each component need to be submitted with the application.

ENVIRONMENTAL FEATURES MAP

map must be prepared by a Maryland licensed forester, licensed landscape architect or qualified professional who meets the requirements of Sec. 20-41.5 of the Unified Land Use Code.

✓ title, date, revisions, scale, and legend	✓ topographic contours and interval
✓ steep slopes greater than 25%	✓ 100-year nontidal floodplain
✓ intermittent and perennial streams	✓ stream buffers (50-ft. width)

✓ proposed limits of disturbance	✓ areas proposed for long-term protection

✓ priority retention areas	✓ priority afforestation areas

✓ soil classifications (SCS Soils Survey) indicating structural limitations, hydric properties, K value greater than 0.35 on slopes of 15% or greater	✓ location of trees or stands which are: rare, threatened, and endangered species; part or associated with a historic structure; designated as a champion tree for species by Maryland DNR or locally; any tree having a diameter measured 4½ feet above the ground of 30" or more; or 75% or more of the diameter, measured at 4½ feet above the ground, of the current state champion tree or that species as designated by the Maryland DNR.
