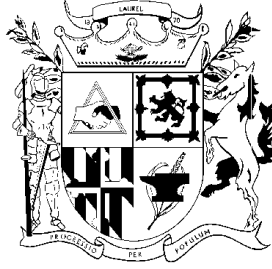

I UNDERSTAND that the approval of this Application by the Historic District Commission is a preliminary determination that the structure described in this Application is eligible for the tax credit, that that the tax, but that this Tax Credit Application may not be finally approved until receipts for actual expenditures in connection with the restoration or preservation of this structure shall have been submitted to the Commission and attested to on the forms provided by this Commission. Work must be in conformity with the Certificate of Approval as provided by the Historic District Commission.

I FURTHER UNDERSTAND that this Tax Credit, if approved, applies to Laurel City Real Estate Taxes only, commencing with the City tax year immediately subsequent to the year in which the restoration or preservation work is completed, and that any unused portion of the tax credit may be carried forward to subsequent tax years, not to exceed five (5) subsequent years. I further understand that this credit may only be allowed on that portion of the work involving exterior features of the structure, which are subject to the authority of the Historic District Commission.

**NO TAX CREDIT SHALL BE ALLOWED FOR ANY RESTORATION OR PRESERVATION WORK WHICH HAS NOT BEEN REVIEWED AND APPROVED, IN ADVANCE, BY THE HISTORIC DISTRICT COMMISSION, EXCEPT FOR GOOD CAUSE SHOWN. WORK STARTED WITHOUT APPROVAL IS SUBJECT TO DENIAL OR 50 PERCENT REDUCTION OF CREDIT, WHICH WOULD BE 5% INSTEAD OF 10% TAX CREDIT.**

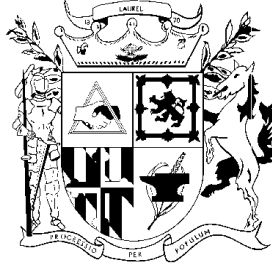
